CLINICAL ETHICS SERVICES

CPB is a trusted provider of ethics education and consultation services.



The nonresponsive patient, on and off hospice, was hospitalized following a fall. Her doctors talked about a feeding tube. Her advance directive said to do nothing, but there was disagreement among her children. Ryan Pferdehirt, a CPB bioethicist, received a message from the attending physician:

"We need you in this room."

When Ryan arrived, the patient's children were waiting. Ryan listened. "Why do you want her to have a feeding tube?," he asked.

One said, "I don't want her to be hungry." Ryan explained, "It's not like that. We cannot be really sure, but from what we know her brain knows what's going on and will not prioritize hunger."

He suggested that it would be more beneficial to focus on comfort measures. After 30 minutes of conversation, the family agreed to change code status to comfort only. The patient died soon after, her children – now at peace with their decision – by her side.

With your support, we respond to hundreds of cases like this every year.

You may ask, why did the doctors need a clinical ethicist to resolve the issue? Why not just call the social worker or chaplain?

From an infant born prematurely or a grandmother whose cancer has spread to questions about organ donation or scare resource allocation, a clinical ethicist has been specially trained to join the care team to resolve tense situations with neutrality and compassion.

ETHICAL AI SERVICES

CPB is a trusted partner and resource for responsible development and implementation of AI in healthcare.

The instructor needed an image of the liver of a 75-year old male with stage 4 liver cancer for a class of several hundred medical students. She could purchase a stock or copyrighted image.



Instead, seeking to reduce cost without decreasing quality, she generated the image from a chatbot, such as ChatGPT or Microsoft Designer.

Still, the instructor wasn't sure that the image accurately depicted the liver of a 75-year old male with stage 4 liver cancer.



Lacking a system to evaluate the risks of Al-generated tools, a large academic medical center committed to providing quality healthcare education reached out to CPB for guidance.

Partnering with CPB, the organization created policy for:

- Transparent communication when choosing to use Al-generated images,
- Understanding the risks of using an image that cannot be "vetted," and
- Implementing a procedure to track (and possibly remove) an image if it poses a risk to the organization.

Having dealt with the devastating effects of inequitable care and service with family members and after facing her own near-death experience, Gloria Thomas Anderson recognized something needed to change.
