#### Mini-Video Case Studies

If you have 3 minutes, you'll have time to watch Ryan Pferdehirt's mini-video case studies, a new series we are launching this month with Aaron's story.

Aaron is a 63-year old man. In addition to a bowel obstruction, he is suffering from cancer with a poor prognosis. Factors that make Aaron's case especially challenging include that he has no decision-making capacity due to profound intellectual disability and has lived his entire life in a long-term care facility. When Aaron was admitted, his siblings, Russ and Helen, wanted the medical team to be as aggressive as possible.

Now Aaron is intubated and has lost all consciousness. The siblings disagree about what to do. The medical team has requested an ethics consult to resolve questions like:

- What should the patient's code status be?
- Should the medical team go forward with the trach and peg or prioritize comfort?
- Who is the most appropriate person to speak for Aaron and uphold his autonomy?
- What is the value of patient assent when the patient is not able to give informed consent?
- How important are non-verbal means of patient communication, and does the patient's history impact the team's decision making?

## The Space Between Excitement and Concern: Finding My Seat at the Al Table

Over the last 18 months, <u>Lindsey Jarrett</u>, Vice President of Ethical AI at the Center, has given 24 talks compared to only seven in the 18 months before that. She notes that, while this could be due to many different factors, all of which may be correct, there has undeniably been an explosion of interest in <u>Ethical AI</u>.

"My seat in the middle [of the AI table] is a complicated one," she says, "because I do believe that technology, even AI-enabled ones, can create some really great change, especially for people who need technology in important areas of their lives. I also believe, though, that technology is often built to solve the wrong problem and often perpetuates faulty decisions by humans."

In her blog piece, Lindsey explores views about the potential risks and benefits of Ethical AI in the context of her own position and the past five years of societal upheaval.
